Steering Committee Meeting

Évora, Portugal, 9th – 10th September 2009

Following on from the event in Oviedo a meeting of AT Venture Steering Committee was held in Évora. ADRAL has prepared two study visits to support venture capital companies with the purpose of increasing mutual knowledge and facilitating exchange of experience in the partnership regions. These visits represent an important contribution that will be useful when implementing the activities of the project, namely the knowledge about the main obstacles to the system implementation in companies and its potential.

On September 10th ADRAL organised the seminar - 'Business Angel and Venture Capital in Alentejo Threats & Opportunities' which was attended by several venture capital shareholders, namely Francisco Banha. This seminar intended to raise awareness of policy makers in Portugal in order to boost the venture capital public policies.

Shetland Partners Meet A Real Life "Angel"!

On Tuesday 6th October, Iain Scott, Chairman of Highland Venture Capital, a business angel network based in Inverness in the Highlands of Scotland, gave a presentation to the economic development agency staff in Shetland.

Iain set up the organisation from scratch three years ago. In that time he has brought together almost 40 members, who, between them, have invested £1.3m of their own money in eight start-up companies. The sums injected in each company range between £65,000 and £450,000.

New perspectives on Venture Capital and Business Angels instruments - AT Venture Project Summary

Heralded as a first for Europe, AT Venture is a collaboration between seven partners from four EU countries who all share the common goal of attracting Venture Capital and Business Angel investment into areas outside of their main financial districts.

Providing a platform on which to share knowledge, AT Venture gives the opportunity for each region to contrast and compare their experience of economic development and to create solutions that will improve public VC instruments and BA networks in each area.

Working closely with private VC and BA operators in their locations, particularly those focused in emerging sectors and technologies, AT Venture will:

- Assess and improve the operation and impact of regionally-based, publicly-owned VC instruments in order to promote RTD and to create and develop fast growing companies within the innovation and technology sectors.
- Improve the understanding and access of regionally based SMEs to VC and BA instruments to finance the development of new technologies and RTD activities.
- Highlight to privately run Venture Capital businesses the growth potential of regionally based SMEs and attract new operators to regional VC and BA markets, increasing the availability of VC and BA in the regions, as an alternative SME financing source.

These objectives look jointly for ways of improving the regional capacity to manage and develop their VC and BA instruments, in particular for SMEs, through the exchange of experiences and good practices and development of joint tools and training modules.

The project which runs from April 2009 until September 2011 is part of the Atlantic Area Programme and a beneficiary of ERDF Funding.

Galicia forms one of the 17 regions of Spain and is located in the northwest along the coast (Atlantic Ocean), bordering the north of Portugal. The region has a surface of 29,574 km² and a population of 2,760,000.

Main cities in Galicia are Vigo, A Coruña, and our capital city Santiago de Compostela (an historical city because of its Cathedral and Pilgrim Way). Galicia is a region that has improved its economic structure. Galicia's GDP has accumulated a much higher growth than Spain or the EU.

Located in the northwest of the Iberian Peninsula, the Principality of Asturias has a surface area of 10,604 km² and a population of 1,079,215 inhabitants. One of the main characteristics of the economic structure of Asturias is the importance of the industrial sector for Gross Value Added, a percentage that in 2007 reached 22.5%, well above the national average (18.3%). Services have shown a very strong upward trend in the past decade, and represent the main component of the region's GVA with about 61%.

Ireland, South West Regional Authority

The South West Regional Authority (SWRA) is a statutory public body providing regional government for the counties of Cork and Kerry. SWRA has responsibility for strategic planning in the region. The strategic plan is published through the Regional Planning Guidelines, a document which currently establishes the development programme for the region until 2020. The Regional Planning Guidelines are effectively the implementation of the Irish National Spatial Strategy.

The authority makes recommendations to government on regional investment programmes and monitors and reviews the operation of the National Development Plan.

SWRA has engaged in more than 25 of EU projects in recent years. EU projects are identified as a most valuable method of identifying best practice models in other EU regions and transferring that experience. Our region has been both a contributor to, and recipient of, the process of transnational exchange. The last SWRA project was the Interreg 111B, NWE project, "DRIVE for Growth" (www.driveproject.eu). The objective of the DRIVE project partnership was to enhance connections between the Research and Production communities in each of their regions and ultimately across the European Union. The Project partners were from Ireland, UK and Germany. This theme of activity is continuing now through three new projects in

the IVB (Atlantic Area), AT Venture, AT Clusters and Re-Thinking Entrepreneurship. These project all focus on the sustainable development of the region. They target growth especially in the indigenous industry sector. The projects all focus on partnership networking and development through interregional cooperation programmes. They all target the achievement of regional sustainability and the development of a high quality of life and services.
